1. Qualification process introduction

What is the qualification process?

The qualification process is a process that every Supplier must perform in SAP Ariba platform and is needed to be able to work with Repsol. Once you have the Qualified status, Repsol Buyers will be able to award you on a negotiation event.

This process is managed completely inside SAP Business Network, but this does not mean that the qualification process is global for your SAP Business Network. This process is specific to Repsol.

So, to proceed first **you must have a SAP Business Network account.** If you do not have one, please, follow the *Repsol SAP Ariba Supplier Onboarding* included in the Repsol <u>webpage</u>, register, and create an account.

I have a SAP Business Network, do I need to know something before being able to complete the Qualification process?

As mentioned before, the process is managed inside SAP Business Network, so it will be required that you know how to answer questionnaires and provide certificates in SAP Business Network, so the Repsol team can evaluate your status with the maximum amount of information.

In order to explain these two topics, we include <u>Chapter 2: Questionnaires and</u> <u>Certificates</u>. In this chapter you will learn how to answer questionnaires.

If you are already familiar with this point, please go directly to <u>Chapter 3</u>: <u>Qualification Process</u>, but we encourage you to review chapter 2 just in case.

Could the qualified status expire?

Yes, once you are qualified you will need to renew this status each year, as the information provided will expire.

If I am qualified, can I be disqualified?

In the short term, yes. In this case, Repsol decided for a justified reason that as a Supplier you might not be eligible to work with them.



2. Questionnaires and certificates

What is a questionnaire?

A questionnaire is the way Repsol will request documentation and information through SAP Business Network. This questionnaire could be of a diverse nature. For example, Repsol could request a Certificate or request documents related to Data protection. In each case, it will be specified in the name of the questionnaire clearly so it will be easier for you as a Supplier to manage them.

The questionnaires will be managed in Business Network inside the tab **Ariba Proposals and Questionnaires**. To access this tab, you must click on Business Network next to the SAP logo in the top left corner of the screen. This will open a drop-down tab. Then select this option:



A new screen will be open, and you will be able to access the different events and questionnaires that you are invited to:

How do I answer a questionnaire?

You will receive an email like the one below when Repsol requests you to complete a questionnaire. If you click on **Submit Questionnaire** you will be redirected to the login page (or questionnaire if you are already logged in):

There are different types of questions:

- Attach a document (only **one** document or a zipped folder is allowed to be attached).
- Yes or no question.
- Multiple choice question.
- Text answer.
- Certificate question. It is exclusive of a Certificate request, and it will be explained later in this chapter.

When you enter a questionnaire, you will see a screen like the following:

Here you can see the time remaining to answer the questionnaire at the top right part of the screen, the content of the questionnaire at the left, the questions at the central part of the screen, and the options you have at the bottom part.

These options are:

- Submit entire response: To send the answer
- Save draft: To save and continue in another moment

I have received a Certificate request, how to answer these questions?

If Repsol requests a Certificate (ISO, UNE...), you can identify this questionnaire because in their name will appear Certificate:



These questionnaires work like the questionnaires mentioned before. You can access them in the same way, but the questions inside are different.

In this case, once you access the questionnaire, a screen like the one below will be displayed:

Besides, if you want to attach another certificate of the same type but with another scope, you have to mark **Yes** in the third question. This will open the possibility of attaching another certificate with the same process as we just mentioned.

Each certificate has its own expiration date, it does not matter if you include two certificates in the same questionnaire.

The status of the questionnaire can be the following:

- Not responded: You have not responded to the questionnaire.
- Pending approval: You sent the questionnaire and it is pending to be reviewed by Repsol.
- Approved: Repsol approved the content.
- Rejected: Repsol has not accepted it (in case it is not a questionnaire associated with the qualification process this status will appear as Denied)
- Expiring: If the questionnaire has an expiration date, this means that it is close to expiring
- Expired: This means that the questionnaire is expired and the content is not valid.



In case you answer a Certificate request you will be able to see the status of each certificate individually in the section Certificates of the Ariba Proposals and Questionnaire tab:

The Certificates can have the following status:

- Valid: This means the certificate is approved and validated.
- Expiring: Close to the expiration date.
- Expired: The certificate is expired and it is not valid.

Can these questionnaires expire?

Some of the questionnaires can expire. In these cases, you will receive a notification via email where you will be requested to update the information provided. The notification will be like the following:

What happens if the certificate is going to expire or I need to update it?

The certificate request will be always 'Open' so you can review the answers and resend it to Repsol.

Two months before the certificate expires you will receive an email like the one below:

What happens if the questionnaire is rejected/denied?

If the questionnaire you sent to Repsol is rejected/denied, you can review the answer that you provided by clicking on the questionnaire. If you see the **Revise Response** button it means that you can resend the information to be reviewed again.

If this button is not displayed, the questionnaire is closed and Repsol will decide if they can resend it to you.

3. Qualification process

I have received the email notification, what should I do now?

When Repsol starts the qualification process, you will be notified via email. Once you receive the email (like the one below), you must click on "**Click here**" to start the qualification process.

4. After qualification
