## The CbC report

The Country by Country (CbC) report is part of the OECD¹/G2o¹s BEPS Action Plan, which requires multinationals, in relation to their Corporate Income Tax, to disclose financial and fiscal information on a country basis as well as the identification of the Group's entities and their main activities.

Base erosion and profit shifting (BEPS) refers to tax planning strategies used by multinational enterprises that exploit gaps and mismatches in tax rules to avoid paying tax. Over 135 countries, working together in the OECD Inclusive Framework, are implementing 15 Actions to tackle tax avoidance, improve the coherence of international tax rules and ensure a more transparent tax environment. The CbC report is one of these measures.

## Repsol's responsible taxation

Repsol is aware of its responsibility for the social and economic development of the countries where it operates and knows that the taxes it pays support development and welfare. Therefore, the commitments assumed in the Group's tax policy result in responsible payment of taxes through application of good practices in the management of our tax affairs, transparency and the promotion of cooperative relationships with governments, while avoiding material risks and unnecessary disputes.

This tax policy, which is aligned with the mission and values of the Company and the Sustainable Development Goals, supports Repsol being recognized as a Company that practices integrity and transparency in our tax affairs.

Repsol takes on a commitment to effectively comply with the best practices of responsible taxation and tax governance, through the voluntary monitoring of internationally accepted principles, guidelines and recommendations (B-team, GRI 207 or the OECD standard for tax risk control).

#### Our commitment to transparency

As a result of our determination to be transparent and share relevant information with our stakeholders, we disclose voluntarily our 2019 Country by Country report (CbC) data for the second consecutive year, for the 45 countries in which we have a taxable presence, as it was submitted to the Spanish Tax Authorities in 2020 for automatic exchange with other Tax Authorities. Additional information has been included to facilitate understanding our presence, performance, tax contribution and purpose in each country.

In addition to this report, we voluntarily disclose relevant financial and tax information by country<sup>2</sup>, in compliance with the highest transparency standards and best practices (available in www.repsol.com):


# Our company and business model

Repsol is an integrated and global multi-energy supplier that strives to evolve toward a low-emissions energy model. We produce more than 700,000 barrels of oil a day and operate one of Europe's most efficient system of refining and chemicals and have a widespread network of close to 5,000 service stations in five countries. We are a relevant player in the Spanish electricity and gas market, and operate low-emission power generation assets. Repsol is also a leading operator in sustainable mobility, providing more efficient fuels and new solutions, such as electric charging and gas.

In accordance with the normal practice of the sector, Repsol's activity are structured into two business segments: Upstream (exploration, development and production of crude oil and gas reserves) and Downstream (refining and petrochemicals, transportation, electricity and gas and hydrocarbon marketing).

#### Location of activities

Repsol operates in 45 Countries.

Repsol Group. whose parent Company is the Spanish entity Repsol, S.A., is composed by more than 300 entities organized under business and geographic footprint criteria. The business model, the stage in the investment cycle and business performance drives much of our taxes paid. Our tax data reflect the varied nature of our activities.

Following the principles of our tax strategy, Repsol only incorporates entities when there is a business reason, where the activities are conducted and supported with the necessary employees and assets.

Given the nature of our business, there is usually a close link between the activities conducted and the territories in which we have presence through the exploration and production of hydrocarbons, our refineries and petrochemical facilities or the service stations.

This means that taxes are paid where activities are performed, in line with our business model and thus driven by value creation.

Accordingly, the so-called "mobile activities" (those activities which would be easy to relocate to a different country) are generally conducted in those jurisdictions where there is a business motivation and effective link.

In fact, most of the mobile activities are conducted in Spain (IP management, trading, holding, etc.) which is the jurisdiction of the Group's head office.

Thus, Repsol policy is not to shift profits through the use of mobile activities structures, being profits subject to tax in countries where activities are conducted.

#### Intangibles

- All the Group Intellectual property (IP) is located in Spain and mostly refers to R&D intangibles and the Repsol trademark.
- There are no companies exclusively engaged in the Group IP management but all the relevant functions related to the IP (development, enhancement, maintenance, exploitation and protection) are centralized in Spain.

#### Tandina

- Trading activity is mainly conducted in Spain, supported with a significant number of employees.
- Trading activities are also conducted in US, Peru and Singapore, focused on their respective regional markets.

#### Reinsurance

- The Group covers its main global risks through a standard mechanism in the sector called "captive insurance".
- This international activity is conducted in the EU [Luxembourg] since 1990 through an entity subject to the supervision and control of the Luxembourgish regulator.

#### Financing

- The group financing activities are conducted through the company's hubs located in Spain, The Netherlands and Luxembourg.
- Presence in the Netherlands since 1991. Bonds issuance and short-term commercial paper in the international stock markets.
- Luxembourg plays an active role in intragroup financing activities through TE Holdings, S.à.r.l. Said activities currently focus on the financing of group's E&P assets in the US and will be expanded to other investments and regions based on treasury policy criteria.

#### Holding

- The Group main holding companies are in Spain (group headquarters) and Canada (headquarters jurisdiction of the former Talisman Group, acquired by Repsol in 2015), through which main investments are channeled.
- Presence of holding companies in other locations are mainly due to acquisition processes and joint venture agreements.

#### Expatriates management

- Activity conducted mostly in Spain.
- Marginal activity in Switzerland only refers to certain employees [44] under a special high mobility regime[E&P technical activities].

Repsol, after taking part in the first OECD ICAP program, has been rated as low risk taxpayer by the tax authorities of main countries of operation.

## Country-by-country report definitions

#### **Definitions**

Data included in the CbC report follow the OECD standards.

See below for definitions of the main CbC reporting terms with a brief description and explanation of reported data by the Repsol Group.

Figures reported are expressed in million euros.

#### Perimeter

Repsol has presence in 45 jurisdictions through 310 entities (including permanent establishments (PEs) and branches). The CbC report shows aggregated country data for entities that consolidate by full and proportionate integration.

The CbC report does not show information about joint ventures and associates<sup>1</sup> (see tax information of these entities in our Integrated management Report and our Tax contribution report in www.repsol.com).

#### Source of data

The main source of information is Repsol Group's 2019 consolidated financial statements (used for Revenues, Profit/(Loss) before income tax and Income tax accrued figures); individual financial statements with local GAAP have been used for balance sheet data (Stated Capital, Retained Earnings and Assets).

#### List of entities and main activities

Repsol is an integrated energy Group with extensive experience in most of the areas of the Oil&Gas industry. Accordingly, Repsol carries out its activities in two main business areas: (i) "Upstream" (exploration and production of crude oil and natural gas reserves) and (ii) "Downstream" business (refining and petrochemistry, trading, marketing of oil, petrochemical and LPG products, marketing, transport and regasification of natural gas and LNG

and generation of electricity and the marketing of electricity and gas).

#### Revenues

Revenues are disclosed in two columns, split between those earned from related parties and those from unrelated parties. Unrelated parties would include non-consolidated joint ventures and associates. Related parties revenues are those earned with entities included in the CbC's perimeter.

Revenues also include net figures such as "Changes in the fair value of financial instruments", "Net exchange gains (losses)" and "Gains (losses) on disposal of financial instruments". For this reason, there can be negative figures in some jurisdictions.

In line with our commitment to transparency, we adhere voluntarily and in advance to the GRI 207 Standard on Taxation. Consequently, in compliance with the requirements of GRI 207-4 Disclosure, we include as Appendix 3 the split of revenues received in each tax jurisdiction with related entities from other tax jurisdictions.

#### Profit (Loss) Before Income Tax

Profit/(Loss) before income tax includes intercompany transactions (except for dividends from constituent entities and equity pickup).

Profits or losses before income tax may include extraordinary accounting adjustments (impairments...) that do not generate an income tax accrued (current year).

#### Income tax paid (on cash basis)

According to OECD's approach, income tax paid includes tax refunds, litigation payments and withholding tax. In some jurisdictions, the income tax paid / (refund) refers to results from previous years.

Our tax contribution to countries is broader than that reflected in the CbC report since other significant payments are not included according to OECD standards (such as royalties, indirect taxes...). See tax information in our integrated management report and tax contribution report in www.repsol.com.

Joint Venture: is a joint arrangement whereby the parties that have joint control of the arrangement (contractually agreed sharing of control) have rights to the net assets of the arrangement. Associate: is an entity over which the investor has significant influence, that is, the power to participate in the financial and operating policy decisions of the investee but is not control or joint control of those policies.

## Income tax accrued (on current year)

Income tax accrued, according to the OECD's definition, includes accrued current tax expense recorded on taxable profits or losses from the year of reporting and does not include deferred taxes or provisions for uncertain tax liabilities.

Since the income tax accrued reflects the information based on the individual financial statements prepared in accordance with their own tax and accounting standards and currency, it may be complex to establish a correlation with the profits or losses before income tax, which are based on consolidated information.

It should also be taken into account that the income tax accrued (current year) may be affected by the application of tax incentives (incentives, deductions...), and accelerated amortization regimes, amongst others.

Tax accrued and tax paid during the year usually are different.

Tax accrued and tax paid could differ due to: (i) payments from previous years (e.g. payments on account and tax refunds), and/or (ii) the utilization of tax credits from previous years.

#### Effective tax rate (ETR)

Even though the ETR data is not required to be disclosed in the CbC report, for the sake of clarity, we are including this information. ETR is calculated

based on the profit/(loss) before income tax and the income tax accrued reported in the CbC report. When a loss before income tax is reported in a jurisdiction and income tax accrued is an expense no ETR is calculated.

## Stated capital and accumulated earnings

Regarding the reported stated capital, it should be taken into account that certain jurisdictions do not categorize some equity figures (shareholders contributions, share issue premium...) as "capital" in a strict sense, for this reason these figures have been omitted to provide a homogeneous vision.

The figures reported as accumulated earning refers to legal reserves, other reserves and prior years income or loss. The source of information for both is the individual financial statements with local GAAP, applying the closing exchange rate to convert them into euro.

#### **Employees**

The reported data is the average staff as of 2019 year end following IFRS<sup>1</sup> criteria. Seconded employees are reported in the jurisdiction where they are seconded.

International Financial Reporting Standards (IFRS) set common rules so that financial statements can be consistent, transparent and comparable around the world. They were established to create a common accounting language, so that businesses and their financial statements can be consistent and reliable from company to company and country to country.

## **Spain**

## Overview of Repsol presence in Spain

Repsol has been present in Spain for over 90 years; this is the jurisdiction of the Group's head office, Repsol, S.A., where all the Group relevant intangible property (IP) is developed and kept and corporate services are rendered from. It is also the most relevant jurisdiction in terms of business activities with 5 refineries, 3 petrochemical facilities and more than 4,000 oil stations. In 2019, Repsol has invested in renewable projects with the constitution of Repsol Renovables, S.L.U. and the acquisition of 16 entities developing wind, solar and/or photovoltaic projects.

Most of the so-called "mobile activities" are conducted in Spain (IP management, trading, holding, etc.) supported by relevant assets and employees. Related party revenues come from the corporate and technical services rendered worldwide as well as commercial transactions within the Downstream business (highly integrated in Spain).

The ETR in Spain is 18%, below the jurisdiction's nominal tax rate, which is explained by the application of tax deductions generated in 2019. In 2018, ETR in this jurisdiction was higher than the Spanish nominal CIT rate since profit before income tax included non-deductible tax provisions. The income tax paid figure is due to the payments on account net of tax refunds from previous years tax payments.

#### Peru

## Overview of Repsol presence in Peru

Peru is one of the most relevant jurisdiction in terms of revenues and business activities since 1996. We currently develop exploration, production, and marketing activities in the country, in addition to the production of natural gas and associated liquids. Repsol also operates La Pampilla refinery - the largest in the country and one of the most important in Latin America- and we have an extensive and modern network of service stations.

The high volume of revenues is explained by the activities performed in Peru, which are supported with employees and relevant assets. Decrease in revenues in 2019 are explained by lower realization prices for crude oil and, especially, gas. Due to the new scenarios assumed, in the context of decarbonization and energy transition envisaged, considering an environment marked by a reduction in the demand for oil products and fuels and an increase in the expected cost of CO2 emissions, net impairment losses before tax were recognized in La Pampilla's refinery's assets, which explains lower profits before income tax. The ETR is broadly above the jurisdiction nominal tax rate, explained by non-deductible impairments from a tax perspective and also explained by amortization's difference and non-deductible tax provisions. In 2018, the ETR lower than the jurisdiction nominal tax rate was explained by the accelerated amortization tax regime applied to the exploration fields.

#### **United States**

## Overview of Repsol presence in United States

Repsol owns significant upstream assets in the US, including the Marcellus Shale, one of the world's largest gas fields, and the discovery made in Alaska in 2017, considered the largest conventional hydrocarbon find on US soil in 30 years. These projects are combined with Downstream activities in Trading and in Wholesale Gas Trading focused on the domestic market.

In November 2019, the 63% interest of its partner, Equinor, in the assets of Eagle Ford was acquired by the Repsol Group. This unconventional asset, located in southern Texas (United States), produces crude oil and gas with associated liquids. With this transaction, Repsol now controls 100% of the asset, operating the asset and incorporating approximately 280 net square kilometers of the mining concession, and 34,000 barrels of oil equivalent daily. United States is one of the jurisdictions where the Group has the most relevant presence in terms of total revenues, arising from the activities performed: Oil&Gas production, NG commercialization, commercialization of Oil&Gas products in the domestic market.

Notwithstanding lower realization prices for crude oil and, especially, gas, in 2019 revenues in this jurisdiction increased mainly explained by the trading activity in this jurisdiction, notably from the sale of distillates and crude oil products in the domestic market. Nonetheless, relevant revenues (volumes) in the trading activity do not necessarily increase margins and, therefore, it had no reflect at profit before income tax level. Throughout the year 2019 a new vision of the future dynamics of Oil&Gas markets has consolidated, with weaker prices, marked by a demand without enough push to compensate for abundant supply, especially of gas, and a progressive decarbonization of the economy. Consequently, net impairment losses before tax were recognized mostly concentrated, as for the United

States, in (i) onshore production assets, which were hurt by the special conditions of the gas market in the United States, and (ii) tax credits, as a result of new price scenarios, that make recovery less likely.

These impairments explain losses before income tax and ETR in this jurisdiction since impairments are non-deductible from a tax perspective. In 2018, ETR was higher than the jurisdiction's nominal tax rate mainly due to accelerated amortization tax regime. The income tax accrued reflects the recognition of a tax credit due to 2019 tax losses. Due to the payment on accounts regime, in 2019 there was a refund of taxes paid. The relevant tangible assets are explained by the E&P and gas activities in the US as well as the rights on the pipeline.

#### Canada

#### Overview of Repsol presence in Canada

In 2015 Repsol completed the acquisition of the Canadian Group Talisman. Consequently, our Upstream projects are carried out in Calgary, the largest city in Alberta. In addition, Repsol manages the CanaportTM LNG receiving and regasification terminal in Saint John, New Brunswick, which is jointly owned by Repsol (75%) and Irving Oil (25%) with a maximum send-out capacity of 1.2 billion cubic feet per day, primarily serving customers in the northeast United States. Canada is one of the jurisdictions where the Group has the most relevant presence in terms of total revenues, which is determined by the nature of the activities performed: Oil&Gas production and purchase and sale of LNG and natural gas.

Throughout the year 2019 a new vision of the future dynamics of Oil&Gas markets has consolidated with weaker prices, marked by a demand without enough push to compensate for abundant supply, especially of gas, and a progressive decarbonization of the economy. Consequently, net impairment losses before tax were recognized mostly concentrated, as for Canada, in (i) onshore production assets, which were hurt by the special conditions of the gas market in Canada, (ii) goodwill arising from the Repsol Oil&Gas Canada Inc. business combination and (iii) tax credits, as a result of new price scenarios that make recovery less likely. In addition, a provision was recorded in 2019 to cover litigious risks regarding ongoing Addax arbitration (open litigation between Repsol and Sinopec derived from the shares of the Chinese State oil company in Talisman Energy UK Ltd, entity operating in the United Kingdom. This procedure began in 2015 before Talisman Group acquisition. In 2019, a

partial arbitration award was issued against Repsol Group's interests. For more details, please refer to note 15 of the 2019 consolidated financial statements). These impairments and the arbitration procedure explain losses before income tax and ETR in this jurisdiction since impairments are non-deductible from a tax perspective.

The income tax accrued reflects as well the recognition of a tax credit due to 2019 tax losses. The income tax paid relates to withholding taxes borne in other jurisdictions by Canadian entities. Relevant figure of tangible assets is explained by the Canaport regasification plant and the gas pipeline rights as well as the E&P assets.

## Singapore

#### Overview of Repsol presence in Singapore

Repsol has presence in Singapore mainly through the Trading business which engages in the supply, sale and transport of oil and other derivative products within the South-East Asia region.

This activity determines the significant volume of revenues achieved in this jurisdiction. However, due to the dynamic and operative of the trading business itself, relevant revenues (volumes) do not necessarily increase margins and, therefore, it has no reflect at the profit before income tax level. The trading activity is supported with employees although no relevant assets are required.

Repsol Trading Singapore is adhered to the Global Trading Program which grants a 10% CIT tax rate provided that certain requirements are met (type of transactions, volume and counterparty).

The Repsol Group's ETR in Singapore is aligned with the jurisdiction's nominal tax rate.

## Overview of Repsol presence in Indonesia

We are present in Indonesia through our Upstream business, owning mineral rights to six blocks. The main projects are Sakakemang (located in the south of the island of Sumatra, where the largest gas discovery in Indonesia in the past 18 years was made and one of the 10 largest hydrocarbon discoveries worldwide in the past twelve months) and Corridor (a non-operated block, producing gas, in which we have a 36% stake).

Relevant revenues and profit before income tax in 2019 are due to the commercialization of natural gas and lower exploration costs, mainly for dry wells, due to a more successful exploration campaign.

The high ETR is explained by the non-deductible accounting purchase price depreciation included in the profit before income tax which affects the tax base.

#### Norway

### Overview of Repsol presence in Norway

Norway is a jurisdiction where only Upstream activities are performed (exploration and production). In 2019, the Norwegian Ministry of Petroleum and Energy announced the adjudication of three new exploratory licenses to Repsol Norge, A.S. as well as the extension of an existing license. Following an agreement with Total, Repsol Norge acquired a 7.65% stake in the Mikkel field in Norway, which currently produces a total of 50,000 barrels of oil equivalent per day. In March 2019, an exploration discovery was made with the Telesto well (7.7% Repsol) in the PL 120 production license located in the Tampen area, in the North Sea (Norway). Repsol Group participated in this oil discovery together with Equinor (operator), Petoro and ConocoPhillips. It is still under evaluation if the discovery is commercial or not. Decrease in revenues and profit before income tax are explained by lower realization prices for crude oil and gas in 2019 accompained with impairments of exploration and production assets.

Group's ETR in Norway can be explained by tax amortization regime applicable to the Oil&Gas companies as well as adjustments for financial items and permanent differences. As the company has had losses derived from its business activities in the past years, for Corporate Income Tax, in 2019 some income generated has been offset towards losses from previous years. Therefore lower income tax has been paid in 2019.

Consequently, net impairment losses before tax were recognized mostly concentrated, as for Algeria, in exploration and development assets, due to lower gas prices, which explains lower profits before income tax and the fact that the ETR of Repsol Group in Algeria is higher than the jurisdiction's nominal tax rate since impairments are non-deductible from a tax perspective. Income tax paid figure is explained by the payments on account regime in Algeria, according to which they are calculated based on results of previous years.

## Malaysia

## Overview of Repsol presence in Malaysia

Repsol owns mineral rights to six development blocks in Malaysia: one exploration block, with a net surface area of 2,104 km2, and five production/development blocks, with a net surface area of 1,022 km2. New wells were started up in the Kinabalu offshore block redevelopment project, located in the west of the Malay basin. In 2017, crude production began in this project, which is operated by Repsol with a 60% working interest. In addition, in May 2019, the Bunga Saffron-1 and Bunga Saffron-1 ST1 wells, located in the offshore PM-03 CAA block, were drilled with positive results. Repsol Group is the operator with a 35% stake.

Revenues in this country are mainly achieved by the Upstream activities performed (also an intragroup regional services provider is located in Malaysia). The decrease in revenues is explained by lower realization prices for crude oil and gas in 2019.

The ETR of Repsol Group in Malaysia is higher than the jurisdiction's nominal tax rate mainly due to amortizations difference. No taxes are due within the year due to previous years business losses compensation. Additionally, the entities received a refund on prior years taxes.

The nature of the activities conducted in this jurisdiction (i.e. financing and holding) determines why neither relevant assets nor very high number of employees are required. We have been in Bolivia since 1994 through our Upstream business. Currently we have mineral rights to 30 blocks located in the Beni, Pie de Monte, Subandino Sur and Subandino Norte basins, as well as a new exploration area in Iñiguazu.

Revenues and profits generated in Bolivia are mostly related to Upstream activities performed by the productive E&P entity. Decrease in revenues is explained by lower realization prices for crude oil and gas. Throughout the year 2019 a new vision of the future dynamics of Oil&Gas markets has consolidated with weaker prices, marked by a demand without enough push to compensate for abundant supply, especially of gas, and a progressive decarbonization of the economy. Consequently, Repsol Group has recognized net impairment losses before tax in production assets in Bolivia. These impairments explain lower profits before income tax and the fact that ETR in this jurisdiction is higher than the nominal tax rate since impairments are non-deductible from a tax perspective.

The income tax paid can be explained by the payments on account regime. In 2018, the ETR of Repsol Group in Bolivia is below the jurisdiction's nominal tax rate due to an adjustment performed according to the Bolivian Regulations in order to absorb the effect of the inflation in the country.

Repsol Group holds 48.33% of YPFB Andina, S.A., through Repsol Bolivia, S.A., which chiefly engages in Oil&Gas exploration, operation and marketing. It operates mainly in Bolivia. Since entities consolidating by the equity method, according to the OECD criteria, are not included in the CbC perimeter, data reported in Bolivia do not include joint venture's information. For joint venture's information and data, please refer to our 2019 Tax contribution report.

#### Colombia

#### Overview of Repsol presence in Colombia

Repsol is in Colombia since 1983, mainly engaged in upstream activities (projects in exploration, development and production), where most of the revenues and profits are generated. In March 2019, the Akacias project, in which Repsol Group has a 45% stake, achieved a record total output of 20 kbbl/d as a result of the drilling work included in Phase I of the Development Plan approved in 2018.

In April 2019, Repsol Group signed two contracts with Colombia's National Hydrocarbons Agency for the exploration and production of the marine blocks GUA OFF-1 and COL-4, located off the Colombian coast in the Caribbean Sea. Repsol Group is the operating company for block GUA-OFF-1 with a 50% stake (Ecopetrol owns the remaining 50%) and in block COL-4, also with a 50% stake (ExxonMobil owns the remaining 50%). Revenues with related parties have significantly increased due to the substitution of Ecopetrol in supplying related trading companies. However, this increase was compensated with a decrease in revenues with third parties due to lower realization prices for crude oil and gas.

Losses achieved in this country are due to the recognition of net impairment losses before tax in production assets in Colombia as a result of delay on the operator's development plans. These impairments explain as well ETR in this jurisdiction. In 2018, the ETR of Repsol Group in Colombia was lower than the jurisdiction's nominal tax rate due to a book-to-tax adjustment carried out according to the Colombian Regulations that allows for the amortization for tax purposes of dry wells once the Government approval is granted. The income tax paid can be explained by the payments on account regime.

#### Vietnam

#### Overview of Repsol presence in Vietnam

Vietnam is a jurisdiction where only Upstream activities are performed. Our work is focused on exploration and production projects, holding the mineral rights to nine blocks: 5 exploration blocks and 4 production/development blocks.

Decrease in revenues is explained by lower realization prices for crude oil and gas and, to a lesser extent, to lower volumes sold in 2019. Throughout the year 2019 a new vision of the future dynamics of Oil&Gas markets has consolidated with weaker prices, marked by a demand without enough push to compensate for abundant supply and a progressive decarbonization of the economy. Consequently, Repsol Group has recognized net impairment losses before tax in exploration and development assets in Vietnam, which explains losses before income tax and ETR in this jurisdiction. In this sense, the new price scenarios do not allow a favorable conclusion on the commercial viability of certain exploratory licenses and drilling capitalized. In 2018, the high ETR was

#### Overview of Repsol presence in Luxembourg

Repsol has been in Luxembourg since 1990. Group's activities performed in this jurisdiction are reinsurance, intra-group financing and holding activities. The reinsurance activities performed in the country (through the captive entity Gaviota RE, S.A.) are subject to the supervision of the Luxembourg regulator Commissariat aux Assurances (CAA). Most of the revenues and profits generated in entities in Luxembourg are earned with related parties, due to the internal financing role of these entities. The nature of the activities conducted in this jurisdiction (i.e. financing and reinsurance) determines why neither relevant assets nor very high number of employees are required.

The ETR of Repsol Group in the Luxembourg is lower than the jurisdiction's nominal tax rate. The use of tax credits generated by tax losses from previous years and the application of the local equalization reserve regime for the reinsurance entity explains the tax information reported. All the companies in Luxembourg are subject to CIT/MBT/NWT and do not benefit from preferential or ad hoc tax regimes. Due to previous years business losses compensation, no income tax was paid in the current year.



#### Ecuador

#### Overview of Repsol presence in Ecuador

Repsol arrived in Ecuador in 2001 to develop exploration and production activities in two blocks under a service provision contract. The main part of our presence in the country is situated within the Waorani reserve in Yasuní National Park, due to the development of our upstream activity regarding Block 16.

Only Upstream activities are performed through our productive entities. The high volume of revenues with related parties steams from oil sales to trading related parties even though there is a decrease in 2019 due to the end of the OCP agreement. The decrease in revenues is explained by lower realization prices for crude oil and gas in 2019.

The profit before income tax and ETR of Repsol Group in Ecuador is explained by non-taxable income from the impairment of accounts receivable for bad debts that are older than two years. It should be noticed that the source

of information for these data are the consolidated financial statements of the Repsol Group. From a local regulation perspective, the impairment of accounts receivable for bad debts does not impact taxable income. The income tax paid relates to withholding tax borne.



#### Russia

#### Overview of Repsol presence in Russia

Our operations in Russia have focused on the Upstream business since 2010. Main activities performed by the companies in Russia relate to pure exploratory activity with no development nor production. No income tax was paid or accrued due to the pure exploratory activity of the entities.

Repsol Group's main activity in Russia is the upstream activity performed through the joint venture (AR Oil and Cas B.V. or AROG) with the company Alliance, which merged with the company NNK in 2014. Repsol interest is 49%. The main assets include two important gas fields: Syskonsyninskoye, which began production at the end of February 2013, and Yuzhno-Khadyryakhinskoye, which is in the final evaluation phase. In June 2019 Repsol signed a memorandum of understanding with Gazprom Neft and Shell to form a joint venture for the exploration of two adjoining license blocks, Leskinsky and Pukhutsyayakhsky, located in the peninsula of Cyudan on the coast of Siberia. Gazprom Neft will have a 50% stake and Repsol and Shell 25% each. The agreement is expected to be completed

In February 2019, the BPTT consortium (30% Repsol) announced the start of gas production from its Angelin platform (West Block), which is remotely operated and is located 60 km off the south-eastern coast of the island of Trinidad, on a 65-meter sheet of water.




