REPSOL INTERNATIONAL FINANCE B.V. CLOSES A 300 MILLION EUR EUROBOND ISSUE

Repsol International Finance B.V. (the “Company”), a wholly-owned subsidiary of Repsol, S.A., has closed a 300 million euro Eurobond issuance, with an issue price of 100.815% and a floating coupon equivalent to EURIBOR 3 months +70 b.p. due May 2023 (equivalent to a EURIBOR 3 months + 30 b.p. reoffer), to be listed on the regulated market of the Luxembourg Stock Exchange.

Settlement is expected to take place on 25 May 2021.

These bonds, guaranteed by Repsol, S.A., are issued under the Company Euro 10,000,000,000 Guaranteed Euro Medium Term Note Dual Programme, approved by the Luxembourg *Commission de Surveillance du Secteur Financier*.
