Tanker ship's agent are requested to report Vessel ETA to La Pampilla Maritime Terminal immediately after leaving last port of call. ETA confirmation must be sent 72, 48, 24, and 12 hours before arrival. Significant changes must be reported as well.

La Pampilla Maritime Terminal will not authorize any tanker ship to berth without the pre-arrival questionnaire, ISPS documents and Repsol vetting acceptance.
