REPSOL INTERNATIONAL FINANCE, B.V. WILL FINALLY ISSUE € 600 MILLION EUROBONDS

Following the official notice published on 1 July 2016, Repsol International Finance, B.V. (the “Company”) announces that the Company has finally agreed the issuance of a 600 million euro 2 years bond (a single series with two tranches of 500 and 100 million euro, respectively) with a floating coupon equivalent to EURIBOR 3 months + 70 b.p., to be listed on the regulated market of the Luxembourg Stock Exchange.

The first tranche has been settled today. Settlement of the second tranche is expected to take place tomorrow.

This bond, guaranteed by Repsol, S.A., is issued under the Company Euro 10,000,000,000 Guaranteed Euro Medium Term Note Programme, approved by the Luxembourg Commission de Surveillance du Secteur Financier.
