

Hecho Relevante

Madrid, 8 de noviembre de 2018

La presente comunicación hace referencia al hecho relevante remitido a la Comisión Nacional del Mercado de Valores el 3 de septiembre de 2018 (número de registro 269284) relativo al programa de recompra de acciones propias puesto en marcha por la Sociedad de conformidad con la autorización conferida por la Junta General de Accionistas celebrada el pasado 11 de mayo de 2018 dentro del punto sexto del orden del día (el “Programa de Recompra”).

Al amparo del Reglamento (UE) 596/2014, de 16 de abril de 2014, sobre abuso de mercado y del Reglamento Delegado (UE) 2016/1052, de 8 de marzo de 2016, por el que se completa el Reglamento sobre abuso de mercado, Repsol comunica que durante el periodo transcurrido entre el 31 de octubre y el 8 de noviembre de 2018, la Sociedad ha llevado a cabo las siguientes operaciones sobre sus propias acciones al amparo del Programa de Recompra:

Como consecuencia de lo anterior, y de acuerdo con los términos del referido Programa de Recompra, la Sociedad comunica igualmente que se da por cumplida la finalidad del Programa de Recompra y que, por tanto, se produce su finalización con anterioridad a la fecha límite de vigencia (que quedó fijada para el 21 de diciembre de 2018).

La adquisición de acciones propias al amparo del Programa de Recompra ha sido efectuada y comunicada de forma periódica de conformidad con lo dispuesto en los artículos 2.2 y 2.3 del Reglamento Delegado (UE) 2016/1052 a través de los hechos relevantes de fecha 12 (número de registro 269511), 20 (número de registro 269766) y 26 de septiembre de 2018 (número de registro 269933), 3 (número de registro 270136), 10 (número de registro 270413), 17 (número de registro 270573), 24 (número de registro 270790) y 31 de octubre de 2018 (número de registro 271112).

Por último, se comunica que se espera ejecutar en un plazo no superior a un mes desde la finalización del Programa de Recompra, la reducción de capital aprobada por la Junta General de Repsol el pasado 11 de mayo de 2018 dentro del punto sexto del orden del día. En virtud de dicha reducción de capital se amortizarán: (i) las 6.072.604 acciones propias existentes en autocartera en fecha 4 abril 2018; y (ii) las 62.705.079 acciones propias, representativas del 3,93%, aproximadamente, del capital social de Repsol, adquiridas en virtud del Programa de Recompra. Es decir, se amortizarán un total de 68.777.683 acciones propias, de un euro de valor nominal cada una y representativas del 4,31%, aproximadamente, del capital social de Repsol a la fecha de esta comunicación.
